

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.pelhambaysoccerclub.com and Pelham Bay Soccer Club LLC dba Pelham Bay Soccer Club and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Pelham Bay Soccer Club include www.pelhambaysoccerclub.com. The Pelham Bay Soccer Club website is a youth soccer club site. By using the Pelham Bay Soccer Club website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Pelham Bay Soccer Club may collect personally identifiable information. For example, when making purchases, you will need to submit information such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Bank Account Numbers
- Credit Card Numbers
- Branch Information

If you purchase Pelham Bay Soccer Club's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Pelham Bay Soccer Club may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information.
